D. City Engineer/Public Works

The report of the City Engineer was presented to the Council.

Wecker Pump Station Replacement Project - Mr. Smith said he found out today that the City should be getting review comments back in a couple of weeks on this project. He reported a Phase I Archeological Survey had to be completed on the site.

Ghent Road Water Main Replacement Project - Mr. Smith said he received approval today for the project so he will be able to finalize getting bids for plans and specifications.

Main Street Streetscape - Phase 2 and Phase 3 - Mr. Smith said he should be getting an update on this project in a few weeks to share with the City Council.

Stemler Road Water Extension - Mr. Smith remarked that sixty-one of the 113 surveys mailed have been returned and all but nine have said they want water.

Carl Street Bridge Replacement Project - Mr. Smith reported that the City has been awarded \$300,000 from the Federal Highway Bridge Fund for the Carl Street Bridge Replacement Project. The funds are for fiscal year 2022. He added that the Monroe County Engineer, Aaron Metzger, submitted the proposal for District 8.

Quarry Road Projects - Mr. Smith said today he received the formal letter from East-West Gateway Council of Governments that the two Quarry Road projects are in their Transportation Improvement Plans for 2019-2022. He said it makes it official and he will be getting an engineering agreement and design started on the two projects.

1. Res. No. 2018-16 - Safe Routes to School Grant - Middle School Connector Trail Project


