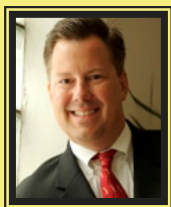

Nice Twice: Accepting gently used clothing/shoes, furniture, toys and household items.

- * Vendors below accepting from Columbia residents only, **photo ID & utility bill required as proof of residency.**
 - * **Reliable Sanitation:** Glass, plastic, cardboard, aluminum and large non-recyclable items (not larger than a recliner).
 - * **CJD E-Cycling:** Computer & audio/video equipment, flat screen TVs & monitors, car and rechargeable batteries, lawn equipment, appliances, & electronics. Small fee to recycle CRT, projection, plasma and console TVs based on size. Smoke detectors (\$10/item fee). *Limited Items: One CRT monitor per tower. (CRT monitors without tower will be a fee of \$5-\$10).*
 - * **Secure Document Destruction Services:** 5 box maximum please.
- Not Accepting:** Paints, light bulbs, alkaline batteries, chemicals and tires.

Help Prevent Vehicle Theft and Burglary

1. **Lock the doors and close the windows.** Don't make it easy for a thief to break into or reach into your vehicle and steal anything of value! When parking your vehicle, make it a habit to double-check that your vehicle's doors are locked and your windows are closed.
2. **Don't leave your vehicle running.** It can be tempting to leave your vehicle running when you're making a quick stop at places such as the store or your child's daycare center, but this also makes it convenient for a thief to hop in and drive away.
3. **Park in well-lit areas.** If you're parking your vehicle after sunset, try to find a spot underneath a streetlight that's well-lit and well-trafficked. Thieves may be less likely to rummage through a vehicle with a spotlight on them and a potential audience just around the corner.
4. **Hide any valuables.** Better yet, avoid keeping valuables in your vehicle at all. If a thief must choose between a seemingly empty vehicle or one with a laptop, cell phone, or wallet in plain view, guess which one they'll choose? If you must leave something important in your vehicle, put the item(s) in your trunk before you reach your destination. Experienced thieves have been known to stake out parking lots, watching for drivers to transfer items to their trunks, and then break into the vehicle's trunk after the driver has left the area. This criminal activity happens more frequently on large parking lots at sporting events, shopping centers and grocery stores.
5. **Invest in an anti-theft system.** Whether it's a steering wheel lock, a window alarm, or an ignition cut-off system, anything that makes a thief work harder could also make your vehicle safer. If it will slow criminals down or potentially get them caught, they'll probably pass.
6. If you see anything suspicious, do not wait — please call the police immediately.



Budget Time

The City is in the process of preparing the budget for the fiscal year beginning May 1, 2019 and ending April 30, 2020. At Committee of the Whole meetings from now until mid-April, City Administrator James Morani and Accounting Manager Linda Sharp will present various components of the budget to the City Council. Topics covered will include projected revenue, projected expenditures, capital projects, equipment purchases, cash flow projections, and fee schedule adjustments. The budget will be posted for public inspection in early April prior to its adoption on April 15.

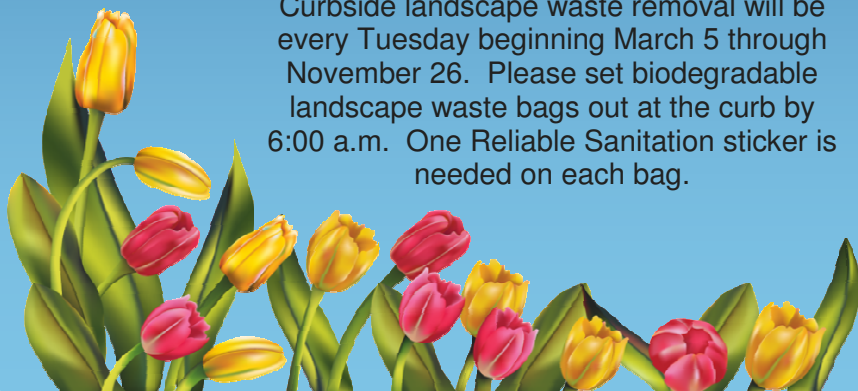

Main Street Streetscape Project - Phase 2, Phase 3 and South Main Street Resurfacing Project

The City of Columbia has combined Main Street Streetscape Phase 2 and 3 with the South Main resurfacing project in an effort to save tax dollars and minimize overall construction times of the three projects. The anticipated bid date for this project is June 2019. The resurfacing portion of the project will remove the existing asphalt surface from Cherry Street to 400 feet north of Illinois Route 3, have repair work performed on the underlying concrete pavement and replace the asphalt surface. The work also includes having all sidewalk curb ramps brought up to current accessibility standards. Side road entrances onto Main Street that are not concrete at this time will have concrete entrances constructed. The Streetscape portion of the project includes the removal and replacement of deteriorated sidewalk and curb and gutter, the construction of ADA compliant intersection curb ramps, brick pavers, decorative cross walks, ornamental street lights and signs, and the addition of trees from Whiteside Street to Oak Street (Phase 2) and Cherry Street to Madison Street (Phase 3). The project is consistent with the City of Columbia's Master Plan to "achieve the preservation and enhancement of Main Street as a vibrant commercial and historical center of the City with a variety of activities and a selection of goods and services where people can walk, ride bicycles or drive to take advantage of these amenities." The current schedule is to complete all the work from Cherry to 400 feet north of Illinois Route 3 by the end of the year and to complete the work from Whiteside to Oak by next summer. The City has obtained approximately \$2 million in Federal STU (Surface Transportation Funds) and ITEP (Illinois Transportation Enhancement Program) Grants to assist in funding these projects.

Residents and motorists are cautioned to watch for detours and lane closures during the construction work. As always, your cooperation and patience is greatly appreciated as the roadway improvements are performed. Please check the City's website for project updates.
