Mr. Morani informed the Council that Mr. Naumann has cut back on his hours as the City Treasurer and as a result Linda Sharp has had to assume some of those duties, some of which require interaction with the banks. Mr. Morani then explained that as a result of needing more authority with the banks, he would like to change the planned "Interim Treasurer" job title to an immediate "Deputy Treasurer". Mr. Morani added this has already been discussed with City Attorney Terry Bruckert and he advised this can be done, but would require a written notice by the Treasurer appointing a Deputy Treasurer. Mr. Morani then presented a signed letter from Mr. Naumann appointing Lind Sharp as Deputy Treasurer. Mr. Morani concluded that an ordinance will be presented at the next meeting adding the job title of Deputy Treasurer, along with adding Mr. Scott Dunakey as the new Director of Community Development and his salary.
