AN ORDINANCE TO AUTHORIZE THE PURCHASE OF
MATERIAL FOR THE WECKER STATION
IMPROVEMENTS FROM SCHULTE SUPPLY, INC OF
EDWARDSVILLE, ILLINOIS FOR THE CITY OF
COLUMBIA, ILLINOIS

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") accepted the bid of Schulte Supply, Inc of Edwardsville, Illinois (the "Supplier") at a regular meeting of the City Council held April 5th, 2010 to supply material for the Wecker Station Improvement for a total price or sum of Twenty Six Thousand One Hundred Ninety-Two Dollars and Forty Cents (\$26,192.40);

WHEREAS, it is necessary and appropriate that the City should purchase the materials for the Wecker Station Improvements from the Supplier as the proposed improvements are the first phase of the upgrading or replacing of the Wecker Station as part of the maintenance and upgrading of the potable water system.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The City Council of the City of Columbia, Illinois does hereby authorize the purchase of the materials from the Supplier for the Wecker Station Improvements per the material proposal received via sealed bid on March 25, 2010 attached hereto.

Section 3. The City Engineer, Ronald J. Williams, P.E., is directed to purchase the materials to be utilized for the Wecker Station Improvements from the Supplier.

Section 4. This Ordinance shall be in full force and effect, from and after its passage, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Agne, and the roll call vote was as follows:






