ORDINANCE NO. 2818

AN ORDINANCE TO AMEND ORDINANCE NO. 2790 WHICH PROVIDED FOR THE APPOINTMENT OF MEMBERS OF CERTAIN BOARDS, COMMISSIONS AND COMMITTEES OF THE CITY OF COLUMBIA, ILLINOIS FOR THE FISCAL YEAR OF THE CITY COMMENCING MAY 1, 2010 AND ENDING APRIL 30, 2011

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") adopted Ordinance No. 2790 on June 07, 2010, and now finds it necessary to amend said ordinance to replace Tourism Advisory Committee members due to change in ownership.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Columbia, Illinois, as follows:

Section 1. Ordinance No. 2790, Section 15, Tourism Advisory Committee, is hereby amended by deleting the words, "David "Skip" Butler from "05/01/10 – 04/30/11", and adding the words, "Kurt Furlong 09/16/10 – 04/30/11" in its stead.

Section 2. The following person is hereby appointed to serve the unexpired term of David "Skip" Butler as a member of the Tourism Advisory Committee, for the following term, to wit:

Section 3. Ordinance No. 2790, Section 15, Tourism Advisory Committee, is hereby amended by deleting the words, "Michele Hiser 05/01/10 – 04/30/11", and adding the words, "Lacey Bochantin 09/16/10 – 04/30/11" in its stead.

Section .4 The following person is hereby appointed to serve the unexpired term of Michelle Hiser as a member of the Tourism Advisory Committee, for the following term, to wit:

Section .5 All other appointments made by, and provisions contained in, said Ordinance No. 2790 not amended hereby, shall remain in full force and effect.

Section .6 The ordinance shall be in full force and effect, and the appointments made herein shall be effective as of the appointment dates shown hereon, from and after its passage as provided by law.


