WHEREAS, the Civic Progress Committee of the City of Columbia, Illinois (hereinafter "Committee") was created as a nine-member advisory group to the Columbia City Council on matters concerning Main Street and business development throughout the City;

WHEREAS, the Committee has adopted a Proposal for Action that seeks involvement from a broader representation of Main Street stakeholders; and

WHEREAS, the City Council of the City of Columbia, Illinois (hereinafter "the City") adopted Ordinance No. 2871 on June 6, 2011, and now finds it necessary to amend said ordinance to expand membership on the Committee in order to meet the above-stated goal.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Columbia, Illinois, as follows:

Section 1. Section 2.49.030 of the Municipal Code of the City is hereby amended to expand membership of the Committee from nine (9) to thirteen (13) members.

Section 2. Ordinance No. 2871, Section 12, is hereby amended to add the following additional members:

<u>Name</u>	<u>Term</u>
Tom Adams	5/01/11 – 4/30/14
Ray Boccardi	5/01/11 – 4/30/12
Lauren Nobbe	5/01/11 – 4/30/12
Barbara Ratz	5/01/11 – 4/30/13

Section 3. Terms for each of these new members shall be staggered as follows:

Two (2) members to serve for a one-year term;
One (1) member to serve for a two-year term;
One (1) member to serve for a three-year term.

Each term to be determined by lot at the first meeting where these new members are seated.

Section 4. All other provisions of Section 2.49.030 of the Municipal Code not amended hereby shall remain in full force and effect.

Section 5. All other appointments made by, and provisions contained in said Ordinance No. 2871 not amended hereby shall remain in full force and effect.

Section 6. The Ordinance shall be in full force and effect, and the appointments made herein shall be effective as of the appointment dates shown hereon, from and after its passage as provided by law.

Alderman Agne moved the adoption of the above and foregoing Resolution; the motion was seconded by Alderman Ebersohl, and the roll call vote was as follows:


