WHEREAS, in the City of Columbia, Illinois ("City") the City Administrator is the City's Budget Officer ("Budget Officer"), and by State law it is the responsibility of the Budget Officer to complete the City's annual Budget and have it approved and adopted by the City Council and thereafter, among other things, it is the responsibility of the Budget Officer to establish and maintain procedures to insure that no expenditures are made by the City, or the City's departments, commissions or boards, which are not authorized by the City's Budget as approved and adopted by the City Council (65 ILCS 5/8-2-9.1 & 8-2-9.2);

WHEREAS, on April 16, 2012 the City enacted its Budget Ordinance No. 2948, which approved and adopted its Budget for the City's fiscal year commencing May 1, 2012 and ending April 30, 2013 ("Budget");

WHEREAS, since the adoption of the City's Budget, the City has received donations from the Sophia and Elmer Oerter Charitable Foundation and the Norman Kutterer Family Foundation in the aggregate amount of \$40,760.50 for the purchase of Automated External Defibrillators ("AEDs") to be used by city employees (and members of the Columbia Fire Protection District) to provide public safety services;

WHEREAS, the receipt of said donations was unknown at the time the City's Budget was approved and adopted by the City Council, and therefore, neither the receipt of the donated funds nor the purchase of the AEDs was included in the Budget;

WHEREAS, the receipt of said donated funds has provided the City with adequate funding for the purchase of the AEDs;

WHEREAS, the Illinois Municipal Code allows and provides that by two-thirds (2/3) vote of the members of the City Council holding office the annual Budget of the City may be revised, provided the City has adequate funds to pay for any such Budget revisions (65 ILCS 5/8-2-9.6); and

WHEREAS, the City Council of the City has found and determined and does hereby declare that it is necessary and appropriate that the City's Budget be changed and amended to allow for the purchase of the AEDs funded by donations received from the Sophia and Elmer Oerter Charitable Foundation and the Norman Kutterer Family Foundation.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The annual Budget of the City of Columbia, Illinois for its fiscal year commencing on May 1, 2012 and ending on April 30, 2013, which was approved and authorized by its City Ordinance No. 2948, enacted April 16, 2012, is hereby changed and amended as follows:

- (A) General Fund – an additional Budget Fund Category numbered 001-00-39100 and titled “Foundation Donations” is hereby added to the Budget in the amount of \$40,761; and
- (B) General Fund – Budget Fund Category 001-00-47400 – Equipment is hereby increased from its original amount of -0- to a revised budgeted amount of \$40,761.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Niemietz moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Reis, and the roll call vote was as follows:


