ORDINANCE NO. 2977

**AN ORDINANCE TO AUTHORIZE THE SIGNING OF A LEASE
EXTENSION AGREEMENT WITH COLUMBIA AMERICAN
LEGION, COLUMBIA POST 581, DISTRICT NO. 22,
DEPARTMENT OF ILLINOIS, AN ILLINOIS CORPORATION,
FOR THE LEASE OF REAL PROPERTY LOCATED IN THE
COLUMBIA AMERICAN LEGION MEMORIAL PARK
SUBDIVISION IN THE CITY OF COLUMBIA, ILLINOIS**

WHEREAS, pursuant to City of Columbia, Illinois Ordinance No. 2815, passed by the City Council and approved by the Mayor on October 18, 2010, the City of Columbia, Illinois ("City"), agreed to lease certain parcels of real estate located in the Columbia American Legion Memorial Park Subdivision from the Columbia American Legion, Columbia Post 581, for a two (2) year period beginning on November 1, 2010 (the "American Legion Memorial Park Lease"); and

WHEREAS, subsequent to the signing of the American Legion Memorial Park Lease, the City applied for and was awarded a grant through the State of Illinois' Open Space Lands Acquisition and Development ("OSLAD") Program to assist the City in the purchase of the property being leased pursuant to the American Legion Memorial Park Lease; and

WHEREAS, the City is currently following the procedures required to receive the OSLAD Grant Program proceeds to be used in purchasing the real estate subject to the American Legion Memorial Park Lease, but is uncertain of the time it will take to receive final approval after all necessary steps have been completed, and all necessary approvals have been received, so the grant funds can be disbursed to the City; and

WHEREAS, the City Council believes and hereby declares that it is in the best interests of the City to extend the term of the American Legion Memorial Park Lease, thereby allowing the continued leasing of subject property by the City until its purchase.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The City Council of the City of Columbia, Illinois, does hereby authorize and direct the Mayor to execute and deliver a lease extension agreement entitled "American Legion Memorial Park Lease Extension", in the form attached hereto, which American Legion Memorial Park Lease Extension is hereby approved as to form, in as many counterparts as the Mayor shall determine, and the City Clerk is hereby authorized and directed to attest the same and affix thereto the corporate seal of the City.

Section 3. This ordinance shall be in full force and effect following its passage and publication in pamphlet form, as provided by law.





AMERICAN LEGION MEMORIAL PARK LEASE EXTENSION

This Lease Extension Agreement is made and entered into to continue the terms and conditions of the Lease Agreement made the 1st day of November, 2010 by and between COLUMBIA AMERICAN LEGION, COLUMBIA POST 581, DISTRICT NO. 22, DEPARTMENT OF ILLINOIS, an Illinois Corporation having an office at #1 Memorial Drive, Columbia, Illinois, (herein referred to as the "lessor" or the "Legion"), and The CITY OF COLUMBIA, ILLINOIS, an Illinois Municipal Corporation and body both corporate and politic having its City Hall at 208 South Rapp Avenue, Columbia, Illinois (herein referred to as the "lessee" or the "City") for parcels of land in the Columbia American Legion Memorial Park Subdivision as described in that previous Agreement.

By entering into this Lease Extension Agreement, both parties agree to extend the terms and conditions of the original Lease Agreement for an additional two (2) years, commencing November 1, 2012, with the language of Section (3) amended to read as follows:

(3) Rent.

Lessee agrees to pay as rent for the premises for the two (2) year term of this lease the sum of Twenty Five Thousand Dollars (\$25,000.00), in addition to all real property taxes, insurance, maintenance expenses and other charges required by the terms of this lease, said sum to be paid by the City to the Legion in equal quarterly installments. In the event this lease is terminated prior to its two (2) year term, the unearned, pro-rata portion of the rental (based upon the quarterly installments required) shall be refunded to the City by the Legion, unless the early termination is due to the default of performance of the lease by the Lessee (in which event the unearned portion of the rental shall be forfeited by the City).

All other terms and conditions of the Lease Agreement not amended hereby shall remain in effect as previously agreed.
