II. STATED PURPOSE

Mayor Hutchinson stated the Executive Session was called to discuss collective negotiating matters between the City of Columbia and its employees or their representatives or deliberations concerning salary schedules for one or more classes of employees.

A. Update/Discussion on Collective Bargaining Negotiations and Employee Salaries

City Administrator Al Hudzik gave an overview of the status of negotiations with the FOP, covering issues that both sides have agreed upon as well as those that still seem to be at an impasse. Mr. Hudzik informed the Council that he, Attorney Mark Weisman and Chief of Police Joe Edwards would be attending a meeting of mediation with the FOP on Wednesday.

Mr. Hudzik also outlined the arbitration process, should that become necessary, covering the deliberation steps of arbitration. He also covered the approximate costs that would be incurred by the City if negotiations reach the arbitration level.

Mr. Hudzik and Chief Edwards led a discussion that included the Council Members and the Mayor related to those issues being negotiated that are still unresolved. It was the consensus of the Mayor and the Council Members that the City has negotiated in good faith and will continue to do so.

After discussion as to parameters, it was the consensus of the Council and the Mayor to grant Mr. Hudzik, Chief Edwards and Attorney Weisman the needed leeway on behalf of the City during the Mediation Hearings.

III. ADJOURNMENT

There being no further business to be brought before the Council in Executive Session, Mayor Hutchinson asked for a motion to return to the Regular Session of the City Council at 9:23 PM.


