AN ORDINANCE AMENDING SECTION 10.44.010 (PROHIBITED PARKING ON CERTAIN PUBLIC STREETS) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE MUNICIPAL CODE OF THE CITY OF COLUMBIA, ILLINOIS BY ADDING ALONG THE EAST SIDE OF LEGION AVENUE FROM LEO STREET TO FIFTY (50) FEET SOUTH OF MAIN STREET AND ALONG THE WEST SIDE OF KUNZ STREET FROM MAIN STREET TO ST. PAUL STREET AND BOTTOM AVENUE TO LEGION AVENUE

WHEREAS, the City Council of the City of Columbia, Illinois has determined it is necessary and appropriate and in the public interest to amend Section 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) in the City of Columbia, Illinois by adding prohibited parking along the East Side of Legion Avenue from Leo Street to Fifty (50) Feet South of Main Street and along the West Side of Kunz Street from Main Street to St. Paul Street and Bottom Avenue to Legion Avenue.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) of the City of Columbia, Illinois Municipal Code is hereby amended by adding

78. Along the East Side of Legion Avenue from Leo Street to Fifty (50) Feet South of Main Street.
79. Along the West Side of Kunz Street from Main Street to St. Paul Street and Bottom Avenue to Legion Avenue.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Holtkamp, and the roll call vote was as follows:


