## ORDINANCE NO. 3086

### AN ORDINANCE TO AMEND ORDINANCE NO. 3056, WHICH PROVIDED FOR THE APPOINTMENT OF MEMBERS OF CERTAIN BOARDS, COMMISSIONS AND COMMITTEES OF THE CITY OF COLUMBIA, ILLINOIS FOR THE FISCAL YEAR OF THE CITY COMMENCING MAY 1, 2013 AND ENDING APRIL 30, 2014

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") adopted Ordinance No. 3056 on August 19, 2013 and now finds it necessary to amend said Ordinance to replace Tourism Advisory Committee members due to resignation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** Ordinance No. 3056, Section 15, Tourism Advisory Committee, is hereby amended by deleting the name, "Ray Boccardi" from "05/01/13 – 04/30/14", and adding the name, "Lisa Schmidt 02/18/14 – 04/30/14" in its stead.

**Section 2.** Ordinance No. 3056, Section 15, Tourism Advisory Committee, is hereby amended by deleting the name, "Amanda Ford" from "05/01/13 – 04/30/14", and adding the name, "Amy French 02/18/14 – 04/30/14" in its stead.

**Section 3.** Ordinance No. 3056, Section 15, Tourism Advisory Committee, is hereby amended by deleting the name, "Rob Willard" from "05/01/13 – 04/30/14", and adding the name, "Linda Emmenegger 02/18/14 – 04/30/14" in its stead.

**Section 4.** All other appointments made by, and provisions contained in, said Ordinance No. 3056 not amended hereby, shall remain in full force and effect.

**Section 5.** This Ordinance shall be in full force and effect, and the appointment made herein shall be effective as of the appointment date shown herein, from and after its passage as provided by law.

ABSENT: Aldermen Roessler, Huch and Mathews.


