**II. STATED PURPOSE**

Mayor Hutchinson stated the Executive Session was called for the purpose of Collective Bargaining Negotiations and Employee Wages. City Administrator Hudzik referenced his previously distributed Memo and its enclosed documents containing the initial requests made by the Department of Public Works personnel through the United Steel Workers, as well as those from the Sworn Police Officers and the Telecommunicators through the Illinois Fraternal Order of Police. Hudzik also stated that this executive session was being held for a review of the initial requests, that additional information would be distributed later in the week, and that a detailed discussion to determine the city's counterproposals and requests would be held at the May 14<sup>th</sup> Personnel Committee Meeting. City Engineer Ron Williams then reviewed the DOPW initial request document, item by item; Police Chief Edwards followed with a review of the Sworn Police Officers, as well as the Telecommunicators, initial request documents on an item by item basis. During their document reviews, both Williams and Edwards presented clarifying information discussed at the initial negotiating sessions and offered opinions on the requested items. A general discussion took place among those in attendance while the DOPW and FOP initial request documents were reviewed.

There being no further business to be brought before the Council in Executive Session, Mayor Hutchinson asked for a motion to return to the Regular Session of the City Council at 8:32 P.M.


