City Administrator Al Hudzik reviewed receipts and revenues of the City for the past five years. He also covered medical and prescription insurance costs of the city for employees from the years 2009 thru 2012.

Mr. Hudzik reviewed an analysis of fringe benefits provided by the City for Police Officers, Telecommunicators and Department of Public Works Employees over the past two years and offered a projection for future increases.

The Mayor, Mr. Hudzik, City Labor Attorney Mark Weisman and the Aldermen discussed several ideas and scenarios regarding fringe benefits and salary leading into the negotiating process with the City's employees.

**III. ADJOURNMENT**




