**AN ORDINANCE APPOINTING AN INTERIM ZONING ADMINISTRATOR
AND ESTABLISHING THE RATE OF COMPENSATION
FOR THE INTERIM ZONING ADMINISTRATOR
FOR THE CITY OF COLUMBIA**

WHEREAS, the City of Columbia, Monroe and St. Clair Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the City is authorized by the Illinois Municipal Code to appoint certain officers of the City, including a Zoning Administrator, and to establish reasonable compensation for said position; and

WHEREAS, the City wishes to appoint an interim Zoning Administrator, until such time as a permanent Zoning Administrator is appointed, and establish the rate of compensation for said interim Zoning Administrator.

NOW THEREFORE BE IT ORDAINED, by the City Council of the City of Columbia, as follows:

Section 1. The preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

Section 2. Justin Osterhage, a current City of Columbia employee, shall be, and is, appointed to serve as the interim Zoning Administrator until such time as the Zoning Administrator position is permanently filled.

Section 3. Justin Osterhage, as the interim Zoning Administrator, shall continue to receive his current rate of compensation plus an annualized stipend of two thousand five hundred dollars (\$2,500.00). The stipend is to be paid in equal amounts over twenty-six (26) pay periods beginning with the pay period commencing December 7, 2014. Justin Osterhage shall receive the stipend payment for each pay period during which he serves as the interim Zoning Administrator.

Section 4. The interim Zoning Administrator is required to attend certain evening meetings. To the extent such meetings occur outside of regular City business hours, mileage shall be paid at the then existing IRS mileage rate of reimbursement. Justin Osterhage, as the interim Zoning Administrator, shall maintain a mileage log accounting for all reimbursable mileage and submit said log for approval to the City Administrator on the first day of each month.

Section 5. This ordinance shall be effective upon passage, approval, and publication as required by law.

Passed by the City Council of the City of Columbia, Illinois, and deposited and filed in the Office of the City Clerk, on the 15th of December, 2014, the vote being taken by yeas and nays, and entered upon the legislative records, as follows:


