

**MINUTES OF THE EXECUTIVE SESSION OF THE COMMITTEE OF THE WHOLE

I. CALL TO ORDER

Chairman Ebersohl called the Executive Session of the Committee of the Whole committee meeting of the City Council of the City of Columbia, Illinois to order at 8:20 P.M.

IV. EMPLOYEE STIPENDS

Mr. Morani said that he spoke to City Attorney Terry Bruckert and Mr. Bruckert said that now that we have a new City Engineer, the temporary stipends authorized by previous ordinances for Assistant City Engineer Tim Ahrens and Building Inspector Justin Osterhage should be listed in the salary ordinance. Mr. Morani said he would like to see these stipends through the end of the current fiscal year, April 30, 2016, due to Mr. Osterhage and Mr. Ahrens still completing additional work even though the city now has a full-time engineer. It was the consensus of the committee to continue paying the stipends to Mr. Osterhage and Mr. Ahrens through the current fiscal year, ending April 30, 2016.

Mr. Morani also informed the committee that a change will have to be made on the Police Department Records Clerk salary as the new hourly salary was not incorporated into the recently-adopted salary ordinance.

Mr. Morani will have an amended salary ordinance for the next City Council meeting showing the two (2) stipends and also the change on the Police Department Records Clerk hourly salary.

V. ADJOURNMENT


MOTION:
