WHEREAS, the City of Columbia ("City"), Monroe and St. Clair Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the City Council of the City of Columbia ("City Council") previously adopted Section 18.82 of the City of Columbia Municipal Code ("City Code"), establishing fees for the City of Columbia's Emergency Medical Services; and

WHEREAS, Section 18.82 of the City Code does not currently provide a fee for non-emergency public assistance services provided to residents and non-residents of the City of Columbia or Monroe County; and

WHEREAS, the City now desires to amend Section 18.82 of the City Code to add a fee for non-emergency public assistance services for residents and non-residents of the City of Columbia or Monroe County.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. That the preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

Section 2. That Section 18.82.0075 shall be added to the City Code and shall read as follows:

"18.82.0075 Non-Emergency Public Assist

—City Resident \$0.00*

*however, any and all public assistance calls in excess of three (3) within any six (6) month period shall be billed at a rate of \$75.00 per occurrence.

—Non-Resident \$75.00"

Section 3. This Ordinance shall take full force and effect after passage, approval, and publication in pamphlet form.


