**AN ORDINANCE TO AMEND TITLE 18 OF THE CITY OF COLUMBIA, ILLINOIS  
MUNICIPAL CODE TO AMEND THE FEES AND CHARGES TO BE ASSESSED FOR  
ANNUAL LIQUOR LICENSES IN THE CITY UNTIL SAID TITLE 18 OF THE CITY'S  
MUNICIPAL CODE IS AGAIN AMENDED BY ORDINANCE OF THE CITY  
ENACTED TO CHANGE SAID FEES AND CHARGES**

WHEREAS, the City Council of the City of Columbia, Illinois ("City") has previously found, determined, and declared that it was necessary and appropriate for the City Council to amend TITLE 18 of the City's Municipal Code, entitled:

"FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND  
BUSINESS LICENCE FEES TO BE ASSESSED FOR THE CONDUCT AND  
OPERATION OF BUSINESSES, OCCUPATIONS, AND PROFESSIONS IN THE  
CITY"

to change some of the fees and charges the City will collect effective upon the passage of this ordinance as provided by law, and to continue in effect after the enactment of the ordinance until said TITLE 18 of the City's Municipal Code is again amended by enactment of a City Ordinance changing said City's fees and charges; and

WHEREAS, the City Council of the City of Columbia, Illinois now desires to amend TITLE 18 of the City's Municipal Code to include fees and charges to be assessed for annual liquor licenses in the City.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** That the preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

**Section 2.** That Chapter 18.95 of the City Code shall be amended to read as follows:

**"Section 18.95.001 Class A-1 – Sale of liquor on/off premises (50% alcohol)**

Sale of liquor on/off premises (50% or more alcohol)	\$600.00
--	----------

**Section 18.95.002 Class A-2 – Sale of liquor on/off premises (50% food/non-alcohol)**

Sale of liquor on/off premises (50% or more food/non-alcohol)	\$600.00
---	----------

**Section 18.95.003 Class B – Sale of liquor on premises only**

Sale of liquor on premises only	\$600.00
Sale of liquor on premises only (not for profit organizations)	\$300.00

<b>Section 18.95.004</b>	<b>Class C – Sale of liquor on/off premises (50% wine)</b>	
	Sale of liquor on/off premises (50% wine)	\$600.00
<b>Section 18.95.005</b>	<b>Class D – Sale of liquor off premises only</b>	
	Sale of liquor off premises only	\$600.00
<b>Section 18.95.006</b>	<b>Class E – Caterer, on/off premises</b>	
	Caterer, on/off premises	\$600.00
<b>Section 18.95.007</b>	<b>Class F – License transferring inventory for special events</b>	
	License transferring inventory for special events	\$35.00 per event
<b>Section 18.95.008</b>	<b>Class G – Special event, not for profit organizations</b>	
	Special event, not for profit organizations	\$35.00 per event
<b>Section 18.95.009</b>	<b>Class H – Brew pub</b>	
	Brew pub	\$600.00

(Note: Event is defined as increments of three (3) consecutive days)"

**Section 3.** This Ordinance shall be in full force and effect immediately upon passage as provided by law.


