WHEREAS, in the City of Columbia, Illinois ("City") the City Administrator is the City's Budget Officer ("Budget Officer"), and by State law it is the responsibility of the Budget Officer to complete the City's annual Budget and have it approved and adopted by the City Council and thereafter, among other things, it is the responsibility of the Budget Officer to establish and maintain procedures to insure that no expenditures are made by the City, or the City's departments, commissions or boards, which are not authorized by the City's Budget as approved and adopted by the City Council (65 ILCS 5/8-2-9.1 & 8-2-9.2);

WHEREAS, on April 17, 2017 the City enacted its Budget Ordinance No. 3321, which approved and adopted its Budget for the City's fiscal year commencing May 1, 2017 and ending April 30, 2018 ("Budget");

WHEREAS, since the adoption of the City's Budget, the City has determined that various revenues will be received and various necessary expenses will be incurred during the current fiscal year of the City, which were not included in the City's Budget Ordinance No. 3321;

WHEREAS, the need to incur such necessary various expenses was unknown at the time the City's Budget was approved and adopted by the City Council, and therefore was not included in the City's Budget;

WHEREAS, the City has ample funds in its various funds to pay for such necessary expenses, or has identified a new source of funding as identified herein;

WHEREAS, the Illinois Municipal Code allows and provides that by two-thirds (2/3) vote of the members of the City Council holding office the annual Budget of the City may be revised, provided the City has adequate funds to pay for any such Budget revisions (65 ILCS 5/8-2-9.6); and

WHEREAS, the City Council of the City has found and determined and does hereby declare that it is necessary and appropriate that the City's Budget be changed and amended to comply with the applicable provisions of Illinois law.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The annual Budget of the City of Columbia, Illinois for its fiscal year commencing on May 1, 2017 and ending on April 30, 2018, which was approved and authorized by its City Ordinance No. 3321, enacted April 17, 2017, is hereby changed and amended as follows:

- (A) General Fund – General Corporate Fund - an additional Budget Fund Category numbered 001-00-49740 and titled “Riebeling Street Property” is hereby added to the Budget in the amount of \$77,000 with excess fund cash to be used to pay the increased budgeted amount; and
- (B) General Fund – Police Department Budget – Budget Fund Category numbered 101-00-49900 and titled “Buildings and Improvements” is hereby increased from its original amount of \$32,095 to a revised budget amount of \$52,095 with excess fund cash to be used to pay the increased budgeted amount.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Roessler moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Huch, and the roll call vote was as follows:






