**AN ORDINANCE AMENDING SECTION 18.65 OF THE CITY OF COLUMBIA
MUNICIPAL CODE TO ESTABLISH FEES AND CHARGES TO BE ASSESSED
FOR SMALL WIRELESS FACILITIES WITHIN THE CITY**

WHEREAS, the City of Columbia ("City"), Monroe and St. Clair Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the City Council of the City of Columbia ("City Council") previously adopted Section 18 of the City of Columbia Municipal Code ("City Code"), establishing fees and charges for City services and business license fees within the City; and

WHEREAS, the Illinois General Assembly recently passed the Small Wireless Facilities Deployment Act (Public Act 100-0585) which provided how local governments may regulate the collocation of small wireless facilities; and

WHEREAS, Section 18 of the City Code does not currently assess a fee, rate, or other charge for small wireless facilities within the City; and

WHEREAS, the City now desires to amend Section 18.65 of the City Code to add fees and rates for small wireless facilities within the City.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. That the preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

Section 2. That Section 18.65 shall be amended and shall read as follows:

"18.65 Small Wireless Facilities

18.65.001 Application and Collocation Fees

Fees and rates for applications and collocations shall be the maximum permitted by applicable law, including but not limited to the amounts in Public Act 100-0585, the "Small Wireless Facilities Deployment Act," as may be hereafter amended, and shall be effective until an ordinance

establishing such lesser or alternative amount is passed by the City Council.

Section 3. This Ordinance shall take full force and effect after passage and approval by the Corporate Authorities.




