AN ORDINANCE AMENDING CHAPTER 10.36 (PARKING GENERALLY) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE MUNICIPAL CODE OF THE CITY BY ADDING A NEW SECTION 10.36.110 (PARKING ON IMPROVED SURFACES WITHIN CITY PARKS) GOVERNING PARKING IN CITY PARKS IN THE CITY OF COLUMBIA, ILLINOIS

WHEREAS, the City Council of the City of Columbia, Illinois has determined that it is necessary and appropriate and in the public interest to amend Chapter 10.36 (Parking Generally) of Title 10, (Vehicles and Traffic) regarding parking in City Parks in the City of Columbia.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Chapter 10.36 (Parking Generally) of Title 10, (Vehicles and Traffic) of the Municipal Code of the City is hereby amended to add Section 10.36.110 (Parking on Improved Surfaces Within City Parks) as follows:

It shall be an offense punishable by fine to park motor vehicles or trailers as defined by the Illinois Vehicle Code in City Parks outside of improved surface areas.

Section 3. PENALTY. Any person, firm, or corporation violating this ordinance shall be fined not less than Seventy-Five (\$75.00) dollars nor more than Seven Hundred Fifty (\$750.00) dollars for each offense.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.


