ORDINANCE NO. 2677

AN ORDINANCE AMENDING SECTION 12.32.020 (HOURS OF OPERATION) AND REPEALING SECTION 12.32.030 (ENTRY AFTER HOURS UNLAWFUL) OF CHAPTER 12.32 (CITY PARKS) OF TITLE 12, OF THE CITY OF COLUMBIA, ILLINOIS MUNICIPAL CODE GOVERNING HOURS OF OPERATION IN THE CITY PARK COMMONLY KNOWN AS THE BOLM-SCHUHKRAFT MEMORIAL PARK IN THE CITY OF COLUMBIA, ILLINOIS

WHEREAS, the City Council of the City of Columbia, Illinois has determined that it is necessary and appropriate and in the public interest to amend Section 12.32.020 (Hours of operation) and to repeal section 12.32.030 (Entry after hours unlawful) of Chapter 12.32 (City parks) of Title 12, (Streets, sidewalks, and public places) regarding hours of operation in the city park commonly known as the Bolm-Schuhkraft Memorial Park in the City of Columbia.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 12.32.020 (Hours of Operation) of Chapter 12.32 (City parks), of Title 12, (Streets, sidewalks, and public places) of the Municipal Code of the City is hereby changed and amended, to read as follows:

“The city park, commonly known as the Bolm-Schuhkraft Memorial Park, located in the city, and the public streets located therein shall be closed, daily, from the hour of eleven o'clock p.m. (11 P.M.) until the hour of six o'clock a.m. (6:00 A.M.), except in the case of special events when prior approval by the Columbia City Council has been obtained. It shall be a trespass to enter upon the park premises or city streets located in the park during hours when the park is closed, in violation of a notice which shall be posted by the city at the location where all city streets enter or exit the park.”

Section 3. Section 12.32.030 (Entry after hours unlawful) of Chapter 12.32 (City parks), of Title 12, (Streets, sidewalks, and public places) of the Municipal Code of

the City is hereby repealed.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.


