AN ORDINANCE AMENDING CHAPTER 10.44.010 (PROHIBITED PARKING ON CERTAIN PUBLIC STREETS) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE MUNICIPAL CODE OF THE CITY TO PROHIBIT PARKING ALONG CARL STREET BETWEEN ADMIRAL PARKWAY AND LEGION STREET IN THE CITY OF COLUMBIA, ILLINOIS

WHEREAS, the City Council of the City of Columbia, Illinois has determined it is necessary and appropriate and in the public interest to amend Chapter 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) regarding prohibiting parking along Carl Street between Admiral Parkway and Legion Street in the City of Columbia.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 10.44.010 (Parking Prohibited on Certain Public Streets) of Title 10 (Vehicles and Traffic) of the City of Columbia, Illinois Municipal Code (the introductory paragraph of which states: "At any time it is unlawful to permit any vehicle to park in any of the following places, except when necessary to avoid conflict with other traffic or compliance with the directions of a policeman or traffic control device" is hereby amended by amending subparagraph 33, to read as follows:

33. Along the East Side of Carl Street from the intersection of Legion Street to 192 feet South and along the West Side of Carl Street from the intersection of Legion Street to Admiral Parkway;

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Agne moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Ebersohl, and the roll call vote was as follows:




