B. Ordinance, Planning and Zoning

1. Motion: Recommend to the City Council that City Engineer Ron Williams be authorized to prepare revisions to the language appearing in Section 15.66.080 (Review of Building Permit Applications) of the City's Municipal Code, pertaining to the submittal of a building permit for commercial buildings, including a set of fully designed plans, to the Architectural Review Board as reviewed and discussed in Committee.
2. Motion: Recommend to the City Council that City Engineer Ron Williams be authorized to prepare the necessary revisions to the language appearing in the City's Municipal Code pertaining to the subdivision replatting requirements upon issuance of building permits for 50% of the subdivision's lots, as reviewed and discussed in Committee.
3. Motion: Recommend to the City Council that City Engineer Ron Williams prepare the necessary revisions to the City's Zoning Code to allow for maximum driveway or curb cut widths of (i) forty (40) feet for commercial businesses (with a minimum width to adequately provide for incoming and outgoing traffic); and (ii) thirty (30) feet for residential properties.
